### **Council Meeting Highlights — March 20, 2018**

#### **Bylaw 480-18 Public Notification**

Pursuant to the section 606 of the *Municipal Government Act*, a council must give notice of certain bylaws, resolutions, meetings, public hearings or other things by advertising in a newspaper or other publication circulating in the area, mailing or delivering a notice to every residence in the affected area or by another method provided for in a bylaw. Council approved this bylaw with all three readings.

#### **On-Call/Standby Procedure & Pay #1707-02**

On Call Procedure and Pay Policy #1707-01 is being brought to Council for their review and updating. Council made some revisions relating to the pay structure.

#### **2018 Citizen Satisfaction Survey**

In April of 2017 the Village had a Citizen Satisfaction Survey related to recreation, municipal services and other items pertinent to the Village. Administration asked Council if they wish to do the survey again and if there were any questions they would like to add.

Council agreed to do the survey with questions added relating to the Community Calendar.

#### **2018 Operating Budget**

Council reviewed a DRAFT budget in December 2017 and January 2018. It was brought to Council for approval in principle as the final budget cannot be completed until the Alberta School Foundation Fund is provided by the Province. A public budget meeting will be held on Tuesday, April 10, 2018 at 6:00 p.m.
