Council Highlights May 17, 2016

REDESIGNATION BYLAW

Council granted first reading to redesignate lands along Railway Avenue from Industrial (I) and Highway Commercial (C2) to Direct Control (DC). A public hearing is set for June 21, 2016 during the Regular Council Meeting.

BORROWING BYLAW

Council gave first reading to Borrowing Bylaw 469-16 to borrow up to \$300,000 over 10 years for paving 2nd Avenue West up to Edey Close. Advertisement will be published for the public to comment.

PERSONNEL POLICY

The Personnel Policy was brought back to Council for amendments.

AMSC P-CARD PROGRAM

AMSC/AUMA has a program for municipalities to use when making purchases. The AMSC Purchasing Program was created specifically to address members' needs for cost reduction tools, improved capabilities and greater efficiency. Council decided not to move forward on this program at this time

MAP TERMS OF REFERENCE

Council approved the Terms of Reference for the Municipal Area Partnership.

TRANSFER SURPLUS TO RESERVES

There was a unrestricted surplus of \$78.195 which is to be transferred to the Water and Wastewater Reserve Account.

TRANSFER FROM RESERVES FOR WATER TREATMENT PLANT **UPGRADES**

It has been determined that the discoloration of the water is from raw water getting into the reservoir. To permanently rectify this issue, the reservoir was drained and cleaned. A second issue arose with the pumps being overworked by using the bypass system to take water directly from the water treatment plant to the distribution system. These expenditures were unbudgeted and required a motion from Council to use reserve funds to cover the expenses.

COWBOY TRAIL PARTNER MEMBERSHIP

Council was presented with information on the Cowboy Trail Partnership and a request to remain members for the 2016-2017 membership in the amount of \$383.75. Council approved to the signup for this membership.
