Regular Council Meeting Highlights April 15, 2025

- Official Administrator passed the Level of Service Policy No. 2019-019, with the revised administration hours of service, Tuesday to Thursday, 9 am to 4 pm, commencing May 1, 2025.
- Official Administrator adopted the Disposition of Surplus Policy No. 2003-04.
- Official Administrator requested the village to move forward with the subdivision application with Urban Systems General Advisory Agreement.
- Official Administrator approved the Village of Cremona 2025 Budget, with no changes to the residential mill rate and a slight rise of 2 % to the mill rate for non-residential.
- Official Administrator approved the list of surplus items to be advertised for sale. (if interested call village office 403-637-0400 for the list).
- Official Administrator approved the applications from Ashley Meagher & Alice Laine to sit on the FCSS Advisory Board.
- Official Administrator approved the Village of Cremona to renew their distribution franchise agreement with Atco Gas and Pipelines Ltd.
- Official Administrator rescinded the Village of Cremona's membership to SAEWA due to the fact that they do not give any services to our village.
- Official Administrator appointed May 22 to 25, 2025 10 am to 3pm as the dates for Cremona's Spring Clean-up.
- Official Administrator approved that the Village of Cremona will help the Cremona Hall Board with the cost of the live entertainment for Canada Day celebrations, with the sum of \$750.
