

## Regular Council Meeting Highlights December 16, 2025

- ♦ Council passed Bylaw No. 519-25 ATCO Gas and Pipelines Ltd. Franchise Agreement.
- ♦ Council approved changes to the Level of Service Policy No. 2019-01. Village of Cremona Office hours of operation will now be Monday to Thursday 9am to 4pm, commencing January 5, 2026.
- ♦ Council approved the appointment of Mayor Lamb to represent the Village of Cremona on the Viability Review Study Group (VRSG).
- ♦ Council approved the appointment of Deputy Mayor Liu as the Alternate for the Village of Cremona representative on the Viability Review Study Group (VRSG).
- ♦ Council requested that the CAO bring a path forward summary from Urban Systems regarding the subdivision and sale of Village land for the Special Meeting on January 6, 2026.
- ♦ Council approved that the Village office be closed on December 24, 25, 26, 2025 and January 1, 2026.
- ♦ Council approved the adoption of the Village of Cremona 2025 Budget as the Village of Cremona 2026 Interim Budget until such time as the 2026 budget is passed.
- ♦ Council requested that the CAO email all Council members the Priority Snow Removal Map and to create a policy regarding the same for the next Regular Council Meeting.
