

## Regular Council Meeting Highlights January 20, 2026

- ◆ Council approved the following top three priorities for the Village of Cremona over the next four (4) years. 1.) Paving or chip sealing of both 3rd Street and East Street, 2.) Water plant operations and infrastructure upgrades, and 3.) Policing and safety.
- ◆ Council requested that the CAO advertise the empty seat on the FCSS Advisory Board in hopes of getting a Village resident to join.
- ◆ Council approved the Snow Route Brochure presented by the CAO, with a few minor adjustments.
- ◆ Council directed the CAO to bring back a cost analysis, comparing the cost of streaming our Council Meetings on our website as opposed to using a third party site, such as You Tube.
- ◆ Council approved the Village to advertise and sell surplus items according to Policy # 2003-04, ensuring that items are advertised with all attachments.
- ◆ Council proposed that the Village advertise for a consulting firm to assist with water operations to cut down on costs.
