- Council approved Derald Anderson as Deputy Mayor for the Village of Cremona.

- Council approved that Mayor Reid will receive a cell phone at the expense of the village.
- Council approved that Mayor Reid can hold a key for the Council Chambers & FCSS common area.

Regular Council Meeting Highlights January 21, 2025

- Rescinding the Procedural Bylaw No. 510-24 was tabled by Council.
- Council scheduled the Committee in Whole, Bylaw & Polices for Feb 13, 2025 @ 7 PM.
- Council approved FCSS 2025 external funding as presented by FCSS Coordinator and FCSS Advisory Board.
- Council approved the renewal agreement with Capital Regional Assessment Services Commission Participant Memorandum.
