By-law No. 502-22**

---

**BEING** a Bylaw of the Village of Cremona in the Province of Alberta, for the purpose of which is to authorize several rates of taxation for all purposes of the year 2022.

**WHEREAS**, the Village of Cremona has prepared and adopted detailed estimates of the municipal revenue and expenditures as required, at the regular council meeting held Tuesday May 17<sup>th</sup>, 2022; and

**WHEREAS** the estimated municipal expenditures and transfers set out in the budget for the Village of Cremona for 2022 total \$1,034,406.88: and

**WHEREAS** the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$612,229.00 and the balance of \$417,517.38 is to be raised by general municipal taxation; and

**WHEREAS** the requisitions are:

**WHEREAS** the Council of the Village of Cremona is required each year to levy on the assessed value of all property tax rates sufficient to meet the estimated expenditures and the requisitions; and

**WHEREAS** the Council is authorized to classify assessed property and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M-26, Revised Statutes of Alberta, 2000; and

**WHEREAS** the assessed value of all property in the Village of Cremona as shown on the assessment roll is:

**NOW THEREFORE**, pursuant to Section 326, Municipal Taxation Act, Chapter M-26.1 T.F.S.A. 2000 and amendments thereto, Council of the Village of Cremona duly assembled and pursuant to the Municipal Government Act, Chapter M-26-1 of the Revised Statutes of Alberta enacts as follows:
