7 a) Re-zoning Bylaw 462-15

Bylaw 462-15 is a bylaw to amend Land Use Bylaw 395-06 to change zoning for Ptn. NW 3-30-W5M from Industrial to Public Facility & Recreation. First reading is required before a Public Hearing can be held.

9 a) Outdoor Skating Rink
