Council Meeting Highlights — December 19, 2017

Delegation

Melissa Copley, Chinook's Edge School Division Board Trustee attended the Council meeting to introduce herself and welcomed Council to speak with her on any concerns or issues relating to the school and Chinook's Edge in general.

Bylaw 479-17 Family and **Community Support Services (FCSS)**

The Family and Community Support Services Bylaw came before Council to make changes relating to monthly meetings.

Collins Barrow LLP Audit Plan & Engagement Letter

Council approved the Audit Plan for 2017 Financial Audit and directed the CAO to sign the engagement letter.

MVRWMC Shingle Grind

The Mountain View Regional Waste Management Commission, approved the donating of shingle grind to each member municipality based on the percentage they helped pay for the process of turning the shingle stockpile into a 3/4" minus media. Council accepted 71 tonnes of Shingle Grind material from Mountain View Regional Waste Management Commission and also would take more grind from member municipalities who do not want their share.

Regional Fire Services Partnership Mutual Aid Agreement

Council approved the recommendation of the Regional CAO group for each municipality provide a letter of support to the Town of Carstairs for the application of funding from the Alberta Community Partnership Program. The funding from the program will be utilized to engage a facilitator for the development of a Mutual Aid Agreement for Fire Services and Regional Fire Services Partnership Agreement.

Council also made a resolution to extend the 2012 Mutual Aid Agreement for Fire Services for a one year period (September 30, 2018).

UNPAID UTILITY ACCOUNT NOTICE

Should any combined water and wastewater account or portion thereof remain unpaid for more than sixty (60) days following the date of the billing, the Village of Cremona shall have the right to enforce payment by transfer of the unpaid amount to the property tax account or the right to disconnect the water supply to the property.

There are several payment options available to you:

- Payment by phone or on-line—contact your bank for details;
- 2. In person at the Village Office—we accept cash, cheque and debit;
- Mail—a cheque can be mailed to: Village of Cremona, Box 10, Cremona AB TOM ORO;
- Mail drop box—your payment can be put in the drop box located on the front of the Village Office main doors.

If payment is not received the Village may apply your outstanding balance to your property tax account .

Each Community Group is responsible for adding and maintaining the posting of their events.

Each Community Group is responsible for the security of their user access address as provided by the Village of Cremona.

All events listed must be taking place in the Village of Cremona coverage area or be of interest to the Citizens of the Village of Cremona.

Noncompliance with these rules will result in the user access of the offending group being terminated.

The Village of Cremona reserves the right to edit or delete any event posting at their discretion.

The Village of Cremona will monitor the Events Calendar for misuse and take appropriate action where warranted.

The Village of Cremona reserves the right to change these "Rules of Participation" as they see fit and it is the responsibility of subscribing user groups to make themselves aware of any changes that occur.

As of February 10, 2015, the Village of Cremona provides this service completely free of charge and will continue to do so until such time as the cost of this service is prohibitive. When and if that time comes, service groups may be required to pay a small annual fee to post their events on this calendar.

Suspended access for any Community Group may be appealed by contacting the Village of Cremona.

This Community Events Calendar is intended to be a medium through which individuals and community groups may post and promote events taking place in the Cremona area. It is not for the purpose of promoting or marketing a business venture. Entry of a hyperlink, URL or Internet address in any of the fields on the "Add an Event" form will result in immediate suspension of the community group's access.
