December 20, 2022 Regular Council Meeting Highlights

- Council adopted 2022 Budget as the Village of Cremona 2023 Interim Budget until such time as the 2023 budget is passed
- Council approved the continuing of support payment to The Cremona Library, that being \$2,500.00 annually.
- Council approved the awarding Balzer's Canada Inc. for the Pump Station Piping Upgrade Project.
- Council appointed signing authority to the new CAO.
- Council approved the appointing Janice Shand to the Cremona Library Board, for a three (3) year term.
- Council approved the Village of Cremona Library Bylaw as presented.
