Council Meeting Highlights — September 18, 2018

DELEGATION—DIDSBURY RCMP

Sgt Chad Fournier of the Didsbury RCMP Detachment gave a presentation to Council on the Annual Performance Plan for the Village.

PUBLIC HEARING—MUNICIPAL RESERVE **REMOVAL**

A public hearing for Bylaw 485-18 Municipal Reserve Removal has been set for October 16, 2018 at 6:30 p.m.

ADDRESSING BYLAW

Council approved Addressing Bylaw 486-18 which provides the need for addressing on properties and the numerical sequence that is required.

TAX ASSESSMENT CLASSIFICATION **BYLAW**

Council approved Classification of Assessed Property Bylaw 487-18 which list out the various classes for taxation such as residential, non-residential, commercial, vacant commercial, etc.

DEVELOPMENT AUTHORITY BYLAW

Council approved Development Authority Bylaw 488-18 which brings the bylaw into current compliances.

PROCEDURAL BYLAW

Council directed Administration to bring back the Procedural Bylaw to the October Regular Council meeting to address some issue relating to voting.

COMMUNICIATION DEVICE POLICY

Council requested the CAO to make changes to the policy and bring back a revised policy at a future meeting.

MUNICIPAL PLANNING COMMISSION **BYLAW**

Council directed Administration to bring a new MPC Bylaw to the October Regular Council meeting which will appoint council members as the Municipal Planning Commission.

DONATION WATER VALLEY PLAYSCHOOL

Council approved to donate \$300 to the Water Valley Playschool Annual Ladies Night Fundraiser.

IDP TERMS OF REFERENCE

Council approved the Intermunicipal Development Plan Terms of Reference and appointed the ICC Committee as the IDP committee.

DONATION CREMONA SHOW & SHINE

Council approved to donate \$300 towards the 2018 Cremona/Water Valley Chamber of Commerce Show and Shine event which took place on September 8, 2018.

APPOINTMENTS TO SDAB

Council appointed Phil Hardy as member of the Cremona, Didsbury, Carstairs, and Sundre Intermunicipal Subdivision and Development Appeal Board and Luana Smith as the Clerk to ISDAB. Appointments will be official once the members have the mandatory training offered by Alberta Municipal Affairs.

2019 ATCO GAS FRANCHISE FEE


