Council Meeting Highlights — August 15, 2018

PUBLIC HEARING—ROAD CLOSURE

A public hearing was held on August 15, 2018 to hear from the public about the proposed road closure for a portion of land created on Plan 981 0006 that is adjacent to Lot 1 and Lot 2 on the south side of Railway Avenue. The lane way is not needed to service Lots 1 and 2 and therefore is being closed. First reading to Bylaw 484-18 was held on June 19, 2018. There were no comments or concerns raised at the Public Hearing, therefore the Village of Cremona Council may proceed to 2nd and 3rd Readings of the Bylaw once the Minister of Transportation has signed off.

BYLAW 485-18 MUNICIPAL RESERVE REMOVAL

At the August 15, 2018 Special Council Meeting, Council granted first reading to Bylaw No. 485-18 is to remove the following Municipal Reserve designation as part of the Village of Cremona Subdivision of DC Lands:

1.06 ha of Municipal Reserve, described legally as "A Portion of Lot 9MR, Plan 001 0427

RESOLUTION REQUESTING SUPPORT FOR FAIR TAXATION OF CANNABIS **GROW OPERATIONS**

The Town of Sundre requested council's support of the resolution they made to **AUMA and Minister of Municipal Affairs** to enable municipalities to assess and tax cannabis grow operations at fair market value. If the legislation is not amended, homeowners and businesses will be left to shoulder the burden of servicing cannabis grow operations.

The Village of Cremona Council accepted the request of support from the Town of Sundre as information only.

AUTOMATED BULK WATER STATION

Council approved to change the location of the bulk water station to be adjacent to the pump house. Council also decided to fund this project 100% from Village resources and not to proceed as a joint project with Mountain View County.
